The Board conducted a visioning exercise at its March 15, 2012 meeting. Senior "Door through Door" transit was ranked a priority project, as were homeless programs. The Senior Transit Ad Hoc Committee conferenced called on April 3, 2012. It was confirmed that Santa Monica and West Hollywood are doing pilot programming, but the other communities are unable to pursue at this time, and will monitor the programs. Homeless services were also determined a COG Board priority.

The Committee has reviewed its Work Program to develop recommendations for the Board as to priorities for the Committee. Attached are the approved work program and a draft revised program reflecting the discussion at the February Committee meeting. Review of the work program can continue at the April meeting, prior to recommending it for Board consideration.

The Senior Transit Ad Hoc Committee has produced a draft matrix of senior transit services provided within the COG region. (See attached.) The matrix is becoming a comprehensive data base that is helping the Ad Hoc Committee to learn about each others' programs, and identify areas of possible collaboration, including improving/expanding services and perhaps even reducing costs in some areas. The ad hoc committee is composed of staff from Beverly Hills, Culver City, Santa Monica, West Hollywood, Access Services, City Ride, Los Angeles County, METRO and Council Members' Rosendahl's and Koretz' offices.


