A. WeHo Arts Community Grant Application - Alliance of Los Angeles Playwrights (ALAP)

The Subcommittee will review a WeHo Arts Community Grant application submitted by the Alliance of Los Angeles Playwrights (ALAP) to fund a play reading festival of new

short LGBTQ-themed plays, to be presented during the City's 2018 One City One Pride celebration.

RECOMMENDATION: Consider recommending that the Arts and Cultural Affairs Commission approve a WeHo Arts Community Grant in the amount of \$1,000 to the Alliance of Los Angeles Playwrights (ALAP) to support a play reading festival in accordance with program guidelines and review criteria.

B. 2018 One City One Pride Design Competition

The Subcommittee will review applications received in response to the City's 2018 One City One Pride LGBTQ Arts Festival design competition and consider selecting a design/image that best represents the theme, "Remembrance" for marketing and promotional purposes.

RECOMMENDATION: Select a design/image that best represents the One City One Pride 2018 theme, "Remembrance" for marketing and promotional purposes and forward recommendation to the Arts and Cultural Affairs Commission for ratification.

C. 2018 Summer and Winter Sounds

The Performing Arts and Cultural Affairs Subcommittee will review and select musicians/bands to perform during the City's 2018 Summer Sounds & 2018-19 Winter Sounds Series.

RECOMMENDATIONS:

1. Review and recommend a pool of 7 musicians/bands to perform during the City's 2018 Summer Sounds Series.
2. Review and recommend a pool of 5 musicians/bands to perform during the 2018-19 Winter Sounds Series.
3. Provide staff direction on strategy and funding as appropriate.
