RECOMMENDATION:

It is recommended that the Commission follow the process outlined below to elect a new Chair and Vice Chair.

The process will begin with the Commission electing a Chair:

- The current Chair opens nominations.
- Any Commissioner can place into nomination, the name of a Commissioner for the position of Chair.
- Each name placed into nomination must receive a second to be considered by the Commission on a roll call vote.
- The current Chair closes nominations and requests a roll call vote.
- Staff conducts the roll call vote of the Commission with each Commissioner voting one time for one of the names placed into nomination.
- The nominated Commissioner receiving the majority of votes is elected by the Commission as Chair.

This above outlined process is then followed for election of the Vice-Chair.

The newly elected Chair and Vice-Chair will assume their respective positions at the Commission's next regularly scheduled meeting.
