**A. A VARIANCE REQUEST TO TRANSFER EIGHTY PERCENT OWNERSHIP OF THE PROPOSED CANNABIS CONSUMPTION AREA (EDIBLES) BUSINESS KNOWN AS DOOR NUMBER SIX TO BE LOCATED AT 8228 W. SUNSET BOULEVARD.**

*SUBJECT:* The West Hollywood Business License Commission shall conduct a public hearing to consider a variance request from Door Number Six to allow the transfer of a total of eighty percent ownership in the proposed Cannabis Consumption Area (Edibles) Business from Amy Lund and Laurent Zilber to Freddy Braidy, Kerim Ortanca and Sholom Goodman.

**RECOMMENDATION:** Approve the variance request and Adopt Resolution No. BLC21-0004, "A RESOLUTION OF THE BUSINESS LICENSE COMMISSION OF THE CITY OF WEST HOLLYWOOD APPROVING THE ASSIGNMENT OF EIGHTY PERCENT OF THE OWNERSHIP FOR THE PROPOSED CANNABIS CONSUMPTION AREA (EDIBLES) BUSINESS KNOWN AS DOOR NUMBER SIX."
