PUBLIC HEARING PROCEDURE

1. CHAIR a. Opens hearing with a statement as to the purpose of the hearing.
 b. Explanation of procedure or ground rules.
 c. Method for addressing the Commission.
2. CHAIR Calls for Staff Report.
 (Appropriate staff member makes report.)
3. CHAIR a. Opens the hearing for testimony from those favoring subject. (This includes audience support.)
 b. Opens the hearing for testimony from those opposing subject. (This includes audience opposition.)
4. CHAIR Closes the "audience phase" of hearing. Commission discusses issues. Audience is precluded from participation other than to answer a direct question of the Commission.
5. CHAIR Closes hearing. No further testimony as evidence is received. Commission may discuss subject.
6. CHAIR Following discussion, Chair asks for a motion (for or against) the subject at hand.
7. Following discussion on the motion, a vote is taken and that disposes of the matter.
