AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD AMENDING CHAPTER 1.08 (GENERAL PENALTY PROVISIONS) TO MAKE VIOLATIONS SUBJECT TO ADMINISTRATIVE PENALTY PROVISIONS OF THE WEST HOLLYWOOD MUNICIPAL CODE, ESTABLISHING A NEW SPECIAL EVENTS CHAPTER 5.106 (SPECIAL EVENTS) WITHIN TITLE 5 (BUSINESS LICENSES, REGULATIONS AND PERMITS), REPEALING CHAPTER 19.55 (SPECIAL EVENT PERMITS) WITHIN TITLE 19 (ZONING ORDINANCE), AND FINDING THE ACTION EXEMPT FROM CEQA”
