PUBLIC COMMENT

Public comment on any agenda item may be made during the consideration of that item. All comments on items not listed on the agenda may be made during the time allotted on the agenda to the public. Members of the public may comment by raising a hand and being recognized by the Chair. Speakers shall confine their comments to three minutes per speaker. Unless otherwise noted in the Agenda, the public may only comment on matters that are within the subject matter jurisdiction of the WSCCOG or items listed on the agenda.

Recommended Action: (1) Waive the 60-day notice requirement for the determination of member dues and adopt member dues for FY 2025-26; (2) Adopt the proposed WSCCOG Annual Budget for FY 2025-26.

C. Election of WSCCOG Board Officers for FY 2025-26 (5 min)

Recommended Action: (1) End the term of the current WSCCOG Treasurer (City of Culver City), effective June 12, 2025, to enable the City of Santa Monica to serve as WSCCOG Treasurer for a new three-year term which shall commence on June 13, 2025 and expire on June 12, 2028, (2) Call for nominations for the position of Chair, Vice Chair, and Secretary, (3) Close the nominations; (4) and call for the vote or declare the election by acclamation.

D. *Transportation* - Measure M Multi-Year Subregional Program (MSP) WSCCOG Annual Update (10 min)

Recommended Action: Approve the annual updates to the WSCCOG's Measure M MSP list of projects.

E. *Transportation* - Westside Subregional Bus Infrastructure Network (5 min)

Recommended Action: Authorize WSCCOG staff to collaborate with the Design Working Group to form an Ad Hoc Request for Proposals Working Group which will release and evaluate the request for proposals for consultant services for the Westside Subregional Bus Infrastructure Network project.

F. **Homelessness - Westside Regional Behavioral Health Services Strategic Roadmap** (10 min)

Recommended Action: (1) Approve Capstone Solutions Consulting Group, LLC, the consultant team recommended by WSCCOG Staff and the Request for Proposal Working Group, for the Westside Regional Behavioral Health Services Strategic Roadmap. (2) Authorize the WSCCOG Legal Counsel and WSCCOG Executive Director to draft and execute a contract with Capstone Solutions Consulting Group, LLC, with a scope of work equivalent to the technical approach included in their RFP response and a budget not to exceed \$100,000.

G. **Homelessness - Measure A Local Solutions Fund (LSF) FY 2025-26 Allocation** (5 min)

Recommended Action: (1) Authorize the WSCCOG staff to finalize the FY 2025-26 Statement of Work and Pricing Schedule. (2) Direct the WSCCOG Legal Counsel to review the forthcoming Measure A LSF contract from the County (which will be substantially the same form as the existing agreement). (3) If satisfactory, authorize the WSCCOG Chair to execute the forthcoming Measure A LSF contract.

H. **Housing - Los Angeles County Affordable Housing Solutions Agency (LACAHS)** (15 min)

Recommended Action: (1) Authorize the WSCCOG Executive Director to review and execute the MOU with LACAHS to receive funds on behalf of Beverly Hills, Culver City, Santa Monica, and West Hollywood. (2) Authorize the WSCCOG Executive Director to program up to \$40,320 in LACAHS Technical Assistance funds for WSCCOG staff to coordinate with member cities and external partners to develop programming recommendations for remaining FY 2025-26 LACAHS funds.
