A. UPDATE ON THE HOLLOWAY INTERIM HOUSING PROGRAM

The Disabilities Advisory Board will receive an update on the Holloway Interim Housing Program, a key part of the City's Plan to Address Homelessness. The program will provide safe, supportive housing for West Hollywood adults experiencing chronic homelessness, with stays of 30–90 days and services to support transition into permanent housing.

B. WEST HOLLYWOOD CARE TEAM PROGRAM OVERVIEW

The Disabilities Advisory Board will receive an overview of the West Hollywood Care Team, a 24/7 mobile behavioral health program. The Care Team responds to community members experiencing behavioral health concerns, wellness and social service needs, or other urgent challenges, and plays a key role in connecting residents to longer-term services. The program is available to all West Hollywood community members, whether housed or unhoused, and is designed to provide accessible and compassionate support throughout the community.
