NOTICE IS HEREBY GIVEN that the West Hollywood Community Development Director will hold a Public Hearing to consider the following item:

LOCATIONS: 9015 Sunset Boulevard, West Hollywood, California

REQUEST: The Community Development Director will hold a public hearing regarding a request to extend the hours of operation, including alcohol service, for the newly expanded 2,055 square foot outdoor dining area. The extended outdoor dining area is located in the courtyard area between two buildings (The Roxy and Rainbow Bar and Grill) and would allow outdoor service until 2:00 am daily, consistent with the approved interior restaurant hours and the hours of the existing outdoor patio area.
