6. PUBLIC COMMENT:

Members of the public shall be permitted to speak on each item of business on the agenda when the item is taken up and before action is taken on the item by the Commission. In order to facilitate the conduct of the meeting, the Chair may lengthen or shorten the two or three minute period for all speakers on a particular agenda item based on the number of persons in attendance wishing to speak or the complexity of the matter under consideration. A. 9101 SUNSET BOULEVARD: This proposal is for a new two-sided full motion animated billboard and façade rehabilitation at 9101 Sunset Boulevard (Gil Turner's), a designated cultural resource. The Historic Preservation Commission (HPC) will hold a public hearing and provide a recommendation to the Planning Commission and City Council regarding the approval of a Certificate of Appropriateness for changes to the cultural resource located on the same property. In addition, the HPC will review any potential adverse impacts to the potential cultural resource at 9111 Sunset Boulevard.

APPEAL PROCEDURES

Any final determination by the Historic Preservation Commission may be appealed, and such appeal must be filed within ten (10) calendar days after the Historic Preservation Commission action. This appeal shall be made in written form to the City Clerk's Office, accompanied by an appeal fee or required number of signatures.

The City Clerk, upon filing of said appeal, will set petition for a public hearing before the City of West Hollywood's City Council (or Historic Preservation Commission as appropriate) at the earliest date.

If you challenge any City of West Hollywood decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing described on this agenda, or in a written correspondence delivered to the Historic Preservation Commission at, or prior to, the public hearing.
