A. AN APPLICATION BY CRUZZT LLC., DBA ZPIZZA, LOCATED AT 8943 SANTA MONICA BOULEVARD, FOR AN EXTENDED HOUR BUSINESS LICENSE TO OPERATE UNTIL 4:00 A.M., SEVEN DAYS A WEEK

SUBJECT: The West Hollywood Business License Commission shall conduct a public hearing to consider the application for an Extended Hour Business License to operate until 4:00 a.m., seven days a week, for a restaurant known as ZPizza, located at 8943 Santa Monica Boulevard.

B. AN APPLICATION BY MYSON ENTERPRISES INC., DBA MCDONALD'S #1411, LOCATED AT 1133 LA BREA AVENUE, TO MODIFY THE EXISTING EXTENDED HOUR BUSINESS LICENSE NO. EXT-000070-2025 TO INCREASE THE RESTAURANT'S INTERIOR DINING HOURS TO OPERATE BETWEEN 2:00 A.M. AND 5:00 A.M., SEVEN DAYS A WEEK

SUBJECT: The West Hollywood Business License Commission shall conduct a public hearing to consider the application to modify the existing Extended Hour Business License No. EXT-000070-2025 to increase the restaurant's interior dining hours to operate between 2:00 a.m. and 5:00 a.m., seven days a week, for a business known as McDonald's, located at 1133 La Brea Avenue.

Any final determination by the Business License Commission may be appealed, and such appeal must be filed within fifteen (15) calendar days after the Business License Commission action. This appeal shall be made in written form to the City Clerk’s Office, accompanied by an appeal fee.

The City Clerk, upon filing of said appeal, will set petition for a public hearing before the City of West Hollywood’s City Council at the earliest date.

If you challenge any City of West Hollywood decision in court, you may be limited to raising only those issues you or someone else raised at the public hearing described on this agenda, or in a written correspondence delivered to the Business License Commission at, or prior to, the public hearing.
