q. Waste Management Integrated Task Force: On Feb. 27, 1990, the L.A. County Board of Supervisors designated the existing framework of the L.A. County Solid Waste Management Committee as the County's choice to serve as the County Integrated Waste Management Task Force and urged concurrence by local jurisdictions. REMOVED FOR SEPARATE DISCUSSION BUT LISTED HERE FOR CLARITY. Proposition 115: Proposition 115, the so-called "Crime Victim's Initiative", makes numerous significant and complex changes in criminal law and in the judicial procedures that must be followed in criminal cases. The proposition affords no greater constitutional rights than the federal constitution, thereby threatening the right to privacy which is explicitly guaranteed in the California Constitution. ACTION: To approve and adopt Resolution No. 687, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD OPPOSING PROPOSITION 115." Approved as part of the Consent Calendar.

The City's primary contract social service categories will remain essentially the same as in 1988-90;

The City will look at modifications to the way these categories of service are prioritized as the RFP process develops;

In addition to the prioritized categories, the City encourages proposals which would provide social work and crisis intervention to the general population;

The City will accept and review proposals for services which are not identified as priorities. These proposals must clearly demonstrate the need in West Hollywood for the proposed service.

2) Authorize that the planning figure of \$2,019,605 in contract funding be used in the RFP process with the qualification that final funding allocation will be determined by the budget and contract approval processes.

He also reported that it would not be financially feasible to proceed with a parking structure at Santa Monica Boulevard and Kings Road and will recommend that it not be further investigated.
